

IMPORTANT RULES

**ALL ENTRIES MUST BE POSTMARKED
NO LATER THAN MAY 31, 2011**

(ATA FEE \$12.00 - Optional)

1) Eligibility: The Midwestern Tennis Association (MID-TAC) Novice Championships are open to amateur players with 2 years or less playing experience and no prior tournament experience.

2) Entry Fee: Singles: \$15.00
Make all checks and money orders payable to MID-TAC

3) Deadline: Entries must be postmarked on or before May 31, 2011. **No phone or fax entries accepted.**

4) Rules: USTA rules apply for age bracket determinations and tournament play.

5) Matches: All matches will be 8 game Pro Sets. Conventional scoring and first player to 8 wins. **Alternate scoring may be used depending on draw size and/or inclement weather.**

6) Draw:
a) The draw will be held, June 18, 2011, 10:00 am, 2840 W. 85th Street Chicago, IL. 60652-3818 (773) 737-3702

b) At the discretion of the Tournament Director, an event will be cancelled or consolidated if there are an insufficient number of entries.

c) No refunds will be made after the draw is made.

7) Other Rules:
a) Unless otherwise posted, first round play will begin promptly at 8:00 AM, Saturday, July 2, 2011.

b) **Players must be able to serve and keep score.**

c) A player may be required to play at more than one site.

d) **Inclement Weather:** A one-time fee will be charged to offset the cost of indoor courts.

e) **All players are required to register. Registration will be held Friday, July 1, 2011 at the Marriott Indianapolis North, Indianapolis, IN.**
