- Entry Fee:** Adults - \$60.000; Juniors - \$40.00; Social Members - \$40.00 (see attached form)
- Package:** Checks or Money Orders Only – **Checks or money orders should be made payable to your Tennis Club by August 13, 2008.** Package fee covers entry for one Single and one Doubles, the Sunday Night Dinner dance, courtside refreshments and balls for all matches.
- Social participants (i.e., non-playing) - \$40.00 covers all social functions and the Sunday Night Dinner Dance. Fill out the attached “Social Participant” form.

- Entries and fees from each club must be postmarked on or before August 18th.
- Limits for Entries:** Players are limited to two (2) events; one singles and one doubles or two doubles. One doubles must be mixed.
- Minimum No. Players:** All events must have a minimum of eight (8) participants or you will be moved to the next lowest event.
- Indoor Courts:** There will be a \$5.00 fee per person, per day if indoor court time is needed due to inclement weather
- Eligibility:** Players must be current financial members of one of the Tri-City Clubs (Forest City Tennis Club, Motor City Tennis Club, Chicago Prairie Tennis Club). Verification of membership may be requested.
- Tournament Format:** All matches, unless otherwise stated, will be the best two (2) out of three (3) sets, scored under the No-Ad system through the quarters. A twelve (12) point tie-breaker will be played when any set reaches six (6) all. There will be a 30 minute default time on the first day. Players who have not reported ready for play after the match is called will be defaulted.
- Draw:** Draw will be held on Tuesday, August 19, 2008 at 7:00 p.m. Location is to be announced. All team captains must be present with current rankings, players ranked in order of play and seeds determination. If no representative can be sent, please send this information with entries and check. Players will not be added after the draw has been completed. The final draw will be posted by 8:00 p.m., Friday, August 22, 2008.
